



eBanking eDocuments Agreement

Thank you for your interest in electronic documents ("eDocuments") from Allegiance Bank. This service is available to you at no cost, and will allow you to view your eDocuments for all of your accounts on a secure website. As part of the registration process, please read the following Consent and Authorization disclosure and indicate your acceptance at the bottom.

Consent and Authorization for Electronic Transmission of Account Statements and Notices.

In this Consent and Authorization, the words "I," "Me," "My" and "Company" mean each person or Authorized Representative who electronically 'signs' below by clicking the 'Accept' button. The word "Account" means the Login or User ID that I entered in order to access this Consent and Authorization. The words "Account Number" mean any and all accounts held at Allegiance Bank under the Account, including but not limited to accounts such as checking, savings, retirement, money market, certificate of deposit and loans.

1. I understand that pursuant to My Account agreement(s) with Allegiance Bank, I may be entitled to receive periodic Account statements and/or notices in connection with My Account. By indicating My acceptance of these terms and conditions, I authorize Allegiance Bank to discontinue sending Me such periodic Account statements and notices via postal mail service for My Account and to instead deliver such periodic Account statements and notices to me electronically ("eDocuments"). I understand and agree that Allegiance Bank will send Me an email on an ongoing basis to My email address, as indicated below, notifying Me that My eDocument Account statement(s) or notice(s) are ready to be viewed on the Allegiance Bank eBanking website. I understand and agree that I will no longer receive paper copies of My periodic Account statements and notices.

2. I acknowledge that I am an authorized signer or Authorized Representative designated by the Company of the Accounts being accessed. My electronic signature executed in conjunction with this Consent and Authorization and any electronic transaction on this Account shall be legally binding on all owners on the Account including myself or Authorized Representative designated by Company and such any transaction performed pursuant to this Consent and Authorization transaction shall be considered authorized by Me or Company.

3. If any Account Number specified within this Consent and Authorization is a joint or business account, I acknowledge that My consent and authorization has been authorized by each of the authorized signers on the Account and will be legally bound by the terms and conditions of this Consent and Authorization.

4. My ongoing consent to receive subsequent Account statements and notices electronically is voluntary and may be withdrawn at any time. I may withdraw consent at any time by updating my delivery method in eBanking. Upon termination, I understand and agree that I will no longer have access to My Account statements and notices online and that I will receive all account statements and notices in paper form via postal mail service.

5. My computer system meets the minimum system requirements set forth below. In addition, I have and will maintain a printer capable of printing any eDocuments that are made available on the Allegiance Bank eBanking website. In the alternative, I have and will maintain the ability to electronically save and visually display on My computer screen any eDocuments that are made available on the Allegiance Bank eBanking website. I understand that Allegiance Bank recommends that I retain or print a copy of any statement, notice and this Consent and Authorization for My record retention.

6. I agree to maintain a valid, active email address. I must promptly notify Allegiance Bank of any change in My email or postal address by updating this information in the eBanking site. Allegiance Bank is not liable for any third party-incurred fees, other legal liability, or any other issues or liabilities arising from eDocuments or notifications sent to an invalid or inactive email address or postal address that I have provided.

7. I may also request a paper copy of any periodic regular Account statement or notice. A fee may be charged for any such paper copies, subject to the fee as set forth in Allegiance Bank's Schedule of Fees and Charges.

8. I understand and agree that Allegiance Bank reserves the right to change the terms and conditions of this Consent and Authorization. Allegiance Bank will notify Me before the effective date of any change. By

accessing My eDocuments after I receive any notice of change will constitute My agreement to such change(s). Allegiance Bank reserves the right to discontinue the eDocuments program at any time.

9. Security Procedures: I understand that I cannot sign up for the eDocuments program and cannot access My regular Account statements without first signing up for and obtaining an eBanking Password. I AGREE THAT USE OF AN EBANKING PASSWORD TO SIGN UP FOR THE EDOCUMENTS PROGRAM AND TO ACCESS MY ELECTRONIC DOCUMENTS CONSTITUTES A REASONABLE SECURITY PROCEDURE. I further understand that if I disclose My eBanking Password to other people, they may also have the ability to access My regular Account statements and notices, and I will be responsible for any transaction(s) they may complete. I agree to notify Allegiance Bank immediately if I believe any of My Accounts have been accessed or an Access Code has been used without My permission to access My Accounts. The terms and conditions in this Consent and Authorization only apply to the eDocuments program. Provisions in other Allegiance Bank agreements and disclosures, including but not limited to Allegiance Bank's Account Disclosure and in any and all loan agreements and disclosures, may be revised from time to time and remain effective for all other aspects of the accounts involved. I am an authorized signer or authorized representative on this Account. I understand Allegiance Bank will send Me an email notifying Me that My statement(s) are ready to be viewed. In order for Allegiance Bank to notify Me of My eDocuments delivery, it is My responsibility to inform Allegiance Bank with any changes in My email address by updating this information in the eBanking site. I understand I may cancel this authorization at any time upon request at which time the Allegiance Bank will resume mailing of all My future periodic statements and I will no longer have access to My Account statements and notices online.

10. Minimum system requirements: To receive and review disclosures electronically, and to view, download, and print My electronic statements, I understand that I will need (a) a currently supported internet browser tool such as Microsoft Internet Explorer, Mozilla Firefox, Apple Safari, Google Chrome, and (b) a currently supported version of Adobe Acrobat Reader. Cookies and JavaScript must be enabled in the browser options.

11. I understand that if I agree to the Terms and Conditions as described above, I must enter the following confirmation code in the space provided above and select "Continue." If I do not agree with these Terms and Conditions set forth above, I understand that I must select "Decline."
